## SPECIAL STORAGE PRECAU-

- Store in a refrigerator (2°C-8°C).
- Protect from direct sunlight.
- Do not freeze.

- The vaccine remains stable for 18 months from production date stated on the label under the recommended storage conditions.
- Shelf life after reconstitution: Use the vaccine immediately after reconstitution (within two hours in cool conditions).

Brucellosis is a serious bacterial zoonotic disease of sheep and goats. The disease is present in most countries of the world. It causes abortion, orchitis. arthritis, and inflammation of the accessory sex glands. The disease is best prevented and controlled by vaccination.

The vaccine has the following charactaristics.

- Stable.
- Does not produce local or systemic reaction.
- Provides satisfactory protection for several years against Brucella melitensis.
- Vaccination is followed by a good immune response.
