Lyophilisate for suspension for injection live attenuated Lumpy Skin Disease Virus (Neethling strain) Vaccine

STATMENT OF THE ACTIVE SUBSTANCE(S) AND OTHER INGREDIENTS:

- Active substance: Each dose (1 ml) contains a minimum of 10⁴⁰ TCID₅₀ of freeze-dried live attenuated Lumpy Skin Disease Virus strain Neethling.
- Other ingredients
 Bacteriological peptone, trehalose and nonfat dried milk powder.

INDICATIONS:

Prevention of Lumpy skin disease in cattle.

CONTRAINDICATIONS:

Do not vaccinate sick or stressed animals.

ADVERSE REACTIONS:

Very rare:

- Vaccinated cattle may develop swelling at the injection site which dissapears within few days.
- A temporary decrease in milk production may occur.

If you notice any side effects please inform your veterinarian.

TARGET SPECIES:

Cattle.

DOSAGE:

- Administer 1 ml per animal subcutaneously; (preferably at the skin of the neck just in front of the shoulders).
- Vaccinate cattle and calves from unvaccinated cows with a single dose at any age.
- Calves from vaccinated cows should be vaccinated at 3 months of age.
- Vaccinated animals need about 10 days after immunization to develop immunity and animals should develop full immunity after 3 weeks.

ADVICE ON CORRECT ADMINISTRATION:

- · Apply usual aseptic procedures.
- Use only clean, antiseptic or disinfectant-free materials for the preparation of the vaccine solution.
- Dissolve the freeze-dried pellet vaccine with the sterile solvent provided immediately before use.
- Use 25 ml solvent for each 25 doses vaccine vial, 50 ml solvent for each 50 doses vaccine vial, 100 ml solvent for each 100 doses vaccine vial.
- Use the vaccine immediately after reconstitution (within two hours in cool conditions).

WITHDRAWAL PERIOD:

Zero davs.

SPECIAL STORAGE PRECAU-TIONS:

- Store in a refrigerator (2°C-8°C).
- Protect from direct sunlight.
- Keep out of the reach and sight of children.
- The vaccine remains stable for 2 years from production date stated on the label under the recommended storage conditions.
- Shelf life after reconstitution: Use the vaccine immediately after reconstitution (within two hours in cool conditions).

SPECIAL WARNING(S):

special warnings for each target species:

Vaccinate healthy animals only.

Special precautions for use in animals:
Not applicable.

Special precautions to be taken by the person administering the medicinal product to animals:

Although LumpyShield-N vaccine is not pathogenic for humans, care should be taken to avoid accidental injection.

Use during pregnancy, lactation, fertility:

Can be used during pregnancy, lactation and breeding.

Interaction with other medicinal products and other forms of interaction:

No information is available on the safety and efficacy of this vaccine when used with any other veterinary medicinal product. A decision to use this vaccine before and after any other veterinary medicinal product therefore needs to be made on a case by case basis.

Overdose:

Rare:

- Vaccinated cattle may develop swelling at the injection site which dissapears within few days.
- A temporary decrease in milk production may occur.

SPECIAL PRECAUTIONS FOR DISPOSAL:

Any unused veterinary medicinal product or waste materials derived from such veterinary medicinal product should be disposed of in accordance with local requirements.

Lumpy skin disease (LSD) is an important trans-boundary disease caused by LSDV of the poxveridae family. The LSD virus is member of the Capripox Virus family.
